

FIREWOOD REMOVAL PERMIT

Permission is hereby granted permittee described below, subject to the following conditions:

The conditions of this permit are as follow:

1. The Permittee will cut wood from slash piles at the location shown on the attached map.
2. The Permittee is allowed to use motorized vehicles to access slash piles only, other cross-county vehicle travel is prohibited.
3. Some non-green dot roads marked with “No Unauthorized Vehicles” signs can be used to access slash piles, Permittee must have firewood removal permit on hand to use these non-green dot roads. See the attached map for roads available to Permittees.
4. This permit is for wood removal for domestic use only. The Permittee will neither sell, give away, or exchange any of the materials removed.
5. Permittee is required to verify Industrial Fire Precaution Level (IFPL) by checking WA. Department of Natural Resources website prior to operating chainsaws during high fire danger periods. [Industrial Fire Precaution Levels \(IFPL\) | WA - DNR](#)
6. This emailed permit of approval, including the signatures of both the permittee and the WDFW Lands Agent, must be in possession during cutting and transport.
7. All ditches and roads will be left open and repaired by the Permittee if damaged by Permittee’s activities. Trees will not be moved so as to block roads.
8. All vehicles on state land must comply with the state Discover Pass law. RCW 79A.80.080. To prevent fires - No parking on any dry vegetation.
9. The Permittee will comply with all regulations governing state forest as set forth in “Forest and Forest Producers” RCW Title 76.00.
10. The Department of Fish and Wildlife reserves the right of cancellation or suspension at any time, and in the event of noncompliance with this permit, all monies held under this permit shall be forfeited.
11. The Permittee shall save harmless the Department of Fish and Wildlife and all of its representatives from all suits, actions, and claims of any character brought on account of any neglect in safeguarding Permittee’s operations, or on account of any act or omission by the Permittee or from any claims or amount arising or recovered under the Workmen’s Compensation Laws, or any other law, by-laws, ordinances, order or decree.
12. The Permittee shall not cut or remove more than 5 cord(s) at a value of \$10.00 per cord for a total value of \$50.

The rights granted by this permit shall terminate on November 30th, 2024 unless previously cancelled.

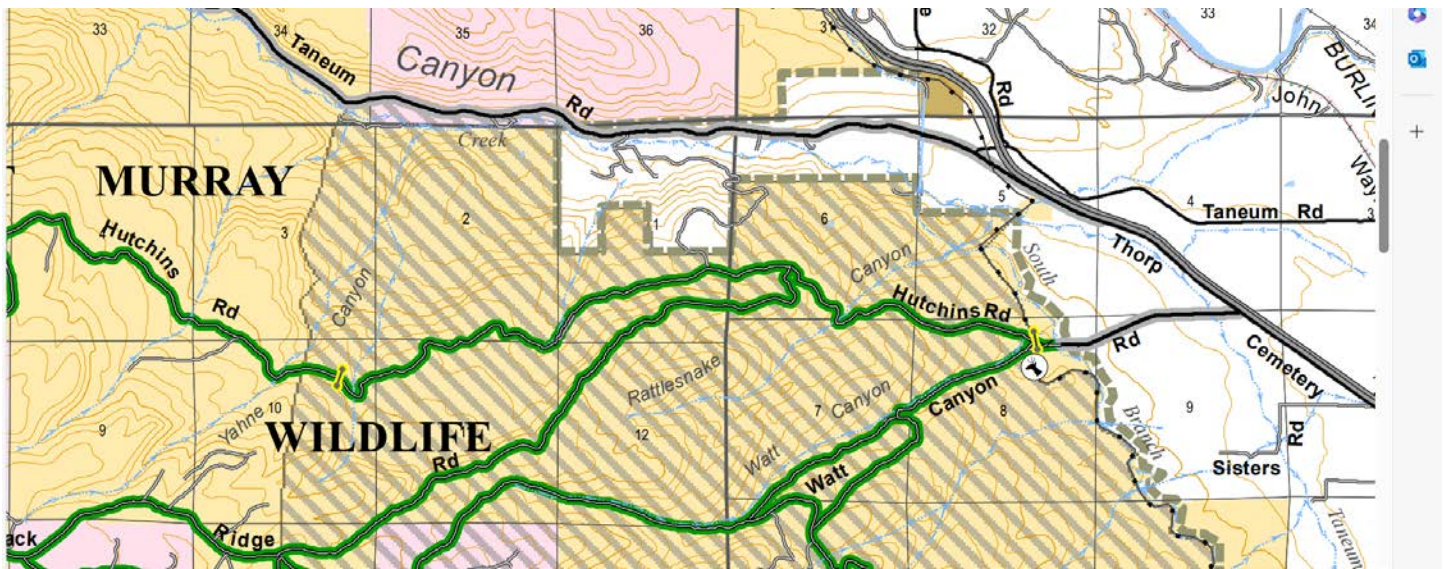
Application Process:
