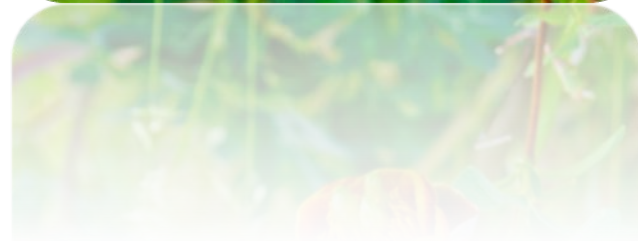

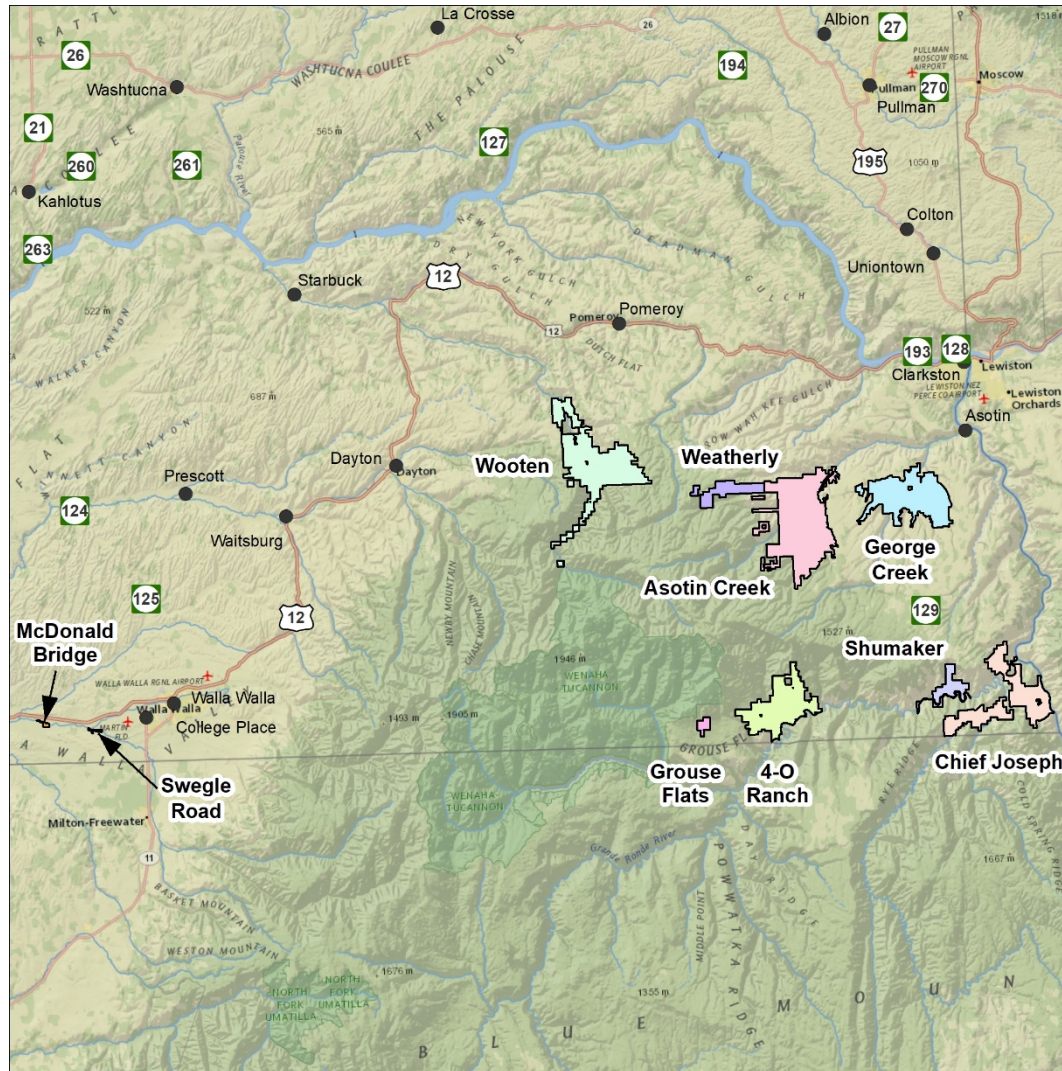

*The process includes tribal, advisory, and public participation in all phases*





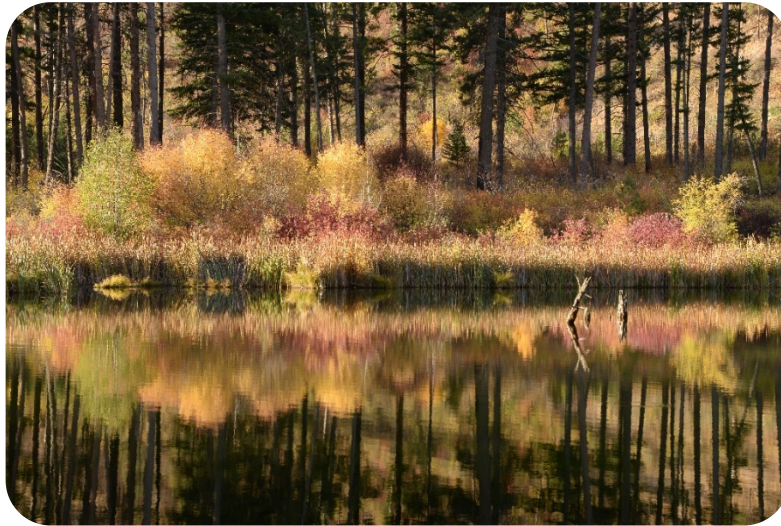

# Vision for Each Wildlife Area

*(followed by unit descriptions)*

The vision for **Asotin Creek** is to protect native grasslands and riparian habitats and big game winter range, while providing recreation and economic opportunities consistent with healthy habitat management (p.24).

The vision for W.T. Wooten is to restore habitat for ESA listed fish and protect big game winter range, while offering quality outdoor education and recreation opportunities, such as fishing, camping, and hunting (p.50).

The vision for **Chief Joseph** is to protect native range and forest habitats, cultural resources, and big game winter range, while offering excellent hunting opportunities and world-class fisheries on the Snake and Grande Ronde Rivers (p.36).

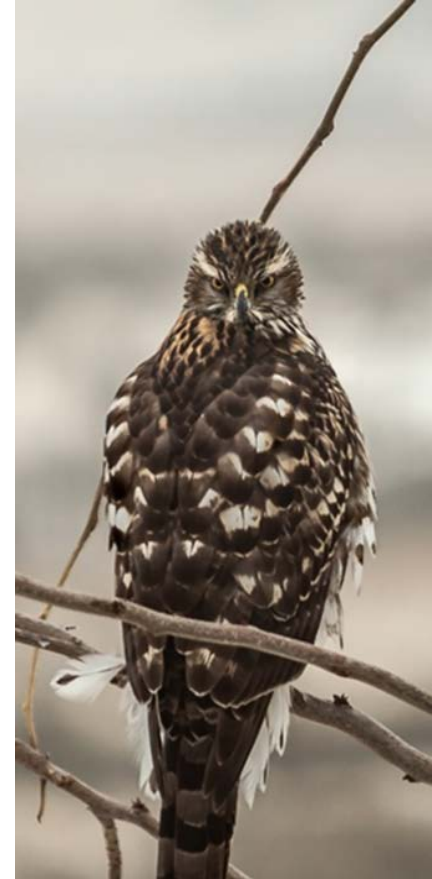

# Goals and Objectives

## Ecological Integrity

- Maintain and improve the ecological condition of the land
- Assess the prairie habitat & develop protection strategy
- Develop a plan to conserve the Spalding's catchfly
- Maintain fences
- Control weeds
- Manage forests



# Sustain species through habitat and population management

- Remove fish barriers
- Protect bighorn sheep from domestic diseases
- Protect wildlife by removing fencing
- Improve wildlife habitat
- Reduce threat of lead poisoning to wildlife
- Reduce and manage human/wildlife conflicts
- Improve floodplain function of the Tucannon River by implementing the Floodplain Management Plan





## Protect wintering wildlife from human disturbance

- Maintain seasonal closures/implement new ones if needed
- Limit off road vehicle travel; close temporary roads

## Achieve species diversity at levels consistent with healthy ecosystems

- Conduct survey for species with greatest conservation need
- Develop species-specific actions



## Provide for and improve opportunities for hunting and fishing

- Increase knowledge of opportunities; promote hunting other than big game
- Review 4-O Ranch Unit special hunt status biennially
- Assess ADA hunt opportunities
- Assess opportunity to expand Green Gulch ATV access
- Continue to provide fishing opportunities on Wooten

## Provide and improve other recreational opportunities

- Develop trail connection plan
- Improve and maintain trails
- Develop/improve campgrounds
- Improve conditions at shooting range
- Assess restroom needs
- Develop interpretive site or signs on 4-O Ranch
- Develop plan for non-consumptive recreation
- Develop recreation maps

## Stakeholder involvement and local relationships

- Continue to meet with Wildlife Area Advisory Committees
- Expand volunteer base
- Continue to allow and look for grazing and agriculture opportunities when beneficial to wildlife and consistent with policies
- Increase patrols to reduce poaching
